## **ORDINANCE NO. 2016:06**

## AN ORDINANCE TO RESCIND ORINANCE 2015:23 ENTITLED "AN ORDINANCE TO AMEND CHAPTER VII OF THE ORDINANCES OF THE BOROUGH OF NEW MILFORD ENTITLED "TRAFFIC," THEREBY AMENDING SECTION 7-9 ENTITLED "BUS STOPS""

**WHEREAS**, The Mayor and Council of the Borough of New Milford adopted ordinance 2015:23 on December 14, 2015; and

**WHEREAS**, the Mayor and Council believe that it is in the best interest of the residents of New Milford to rescind Ordinance 2015:23;

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and Council of the Borough of New Milford that Ordinance 2015:23 is hereby rescinded and Chapter VII, Section 7-9, Bus Stops, is hereby amended to reinstate the following:

## River Road/northbound/east side:

- a. Ridge Street (far side) beginning at Ridge Street's northerly curbline and extending 135 feet north thereof.
- h. Fulton Street (near side) beginning at Fulton Street's southerly curbline and extending 105 feet south thereof.
- i. Center Street (near side) beginning at Fulton Street's southerly curbline and extending 105 feet south thereof.
- j. McKinley Avenue (far side) beginning at McKinley Avenue's northerly curbline and extending 100 feet north thereof.
- k. Voorhis Avenue (far side) beginning at Voorhis Avenue's northerly curbline and extending 100 feet north thereof.
- 1. Cedar Road (near side) beginning at Cedar Road's southerly curbline and extending 105 feet south thereof.
- m. Stockton Street (near side) beginning at Stockton Street's southerly curbline and extending 105 feet south thereof.
- o. Linden Place (far side) beginning at Linden Place's northerly curbline and extending 100 feet north thereof.
- q. Huguenot Drive (mid-block) beginning at Huguenot Drive's northerly curbline and extending 135 feet north thereof.

## River Road/southbound/west side:

- d. (Mid-block) between points 150 feet and 285 feet south of Henley Avenue's southerly curbline.
- g. River Lane (far side) beginning at River Lane's southerly curbline and extending 105 feet south thereof.

- h. Center Street (far side) beginning at Center Street's southerly curbline and extending 100 feet south thereof.
- i. Fulton Street (near side) beginning at Fulton Street's northerly curbline and extending 105 feet north thereof.
- j. Voorhis Avenue (near side) beginning at Voorhis Avenue's northerly curbline and extending 105 feet north thereof.
- k. Holland Avenue (far side) beginning at Holland Avenue's southerly curbline and extending 100 feet south thereof.
- 1. Trenton Street (mid-block) beginning at Trenton Street's southerly curbline and extending 135 feet south thereof.
- n. Dilworth Road (mid-block) beginning at Dilworth Road's northerly curbline and extending 135 feet north thereof.
- q. Clinton Avenue (far side) beginning at Clinton Avenue's southerly curbline and extending 100 feet south thereof.

**BE IT FURTHER ORDAINED** that the remainder of this ordinance remains unchanged and that this amendment shall become effective upon passage and publication in accordance with law.

**BE IT FURTHER ORDAINED** that a copy of this ordinance be forwarded to New Jersey Transit and the New Milford Police Department.
